#### (C) Withdrawal of Categories

ARIA reserves the right to withdraw any Category in any one year if ARIA determines that there is an insufficient number of entries in that Category. ARIA may it its sole discretion place the affected entries in one or more other Categories.

# 2. Conditions of Entry

- (a) All ARIA members are eligible to submit entries for the Awards in the categories specified in section 1(A) (a), (b) and (c) above.
- (b) ARIA members can submit up to eight entries in each individual category for which entries are accepted. Levy Members (Sony, Universal Music and Warner Music) may submit up to twelve entries in each category for which entries are accepted.
- (c) If a particular ARIA member's recordings are distributed by another party, it is the responsibility of that ARIA member to liaise with its distributor to confirm which eligible entity will be submitting the entry to ARIA.
- (d) All Recordings and materials submitted as part of an entry must be non-infringing and authorised materials. If ARIA is advised that any materials submitted as part of an entry are infringing or unauthorised, then ARIA will determine in its sole discretion the eligibility of such materials and the eligibility of the entry.
- (e) ARIA will require each ARIA member to submit certain collateral and assets (for example, RAP Sheets, cover art files, Apple or Spotify IDs, MP3s and YouTube links) as specified in the Guide To Submitting Entries which ARIA will make available to all ARIA members. The conditions set out in the Guide To Submitting Entries also form part of these Conditions of Entry.
- (f) Please note that, if an ARIA member incorrectly enters an artist or recording for any category, that ARIA member will be liable for any additional auditing costs incurred.
- (g) By submitting an entry, the ARIA member agrees that ARIA (and its licensees) may use the submitted collateral and assets in connection with the ARIA Awards voting platform, the ARIA Awards television/online programs and ARIA Awards promotions, activities and marketing without payment to the ARIA member, producer, the relevant artist or any other person.
- (h) Unless an ARIA member otherwise advises ARIA, the ARIA member also consents to the use of any audio recording that it submits to ARIA as a part of its entry being used as music on hold on the telephone systems of ARIA and PPCA.

- (i) As set out in section 5.5, any entries in the category of Best Independent Release must be accompanied by a confirmation form (in the format specified by ARIA, and appended to this document as Appendix B) which is signed by a Director, the Chief Executive Officer or the Chief Financial Officer of the ARIA member. If subsequently requested by ARIA, a properly executed and valid Statutory Declaration (in the format provided by ARIA, and appended to this document as Appendix A) for any entries in the category of Best Independent Release must be signed and returned to ARIA within two business days of any such request. ARIA will determine at its discretion whether the Statutory Declaration that accompanies each entry is valid.
- (j) All entries must be submitted via the designated ARIA online platform within the specified timeframe.
- (k) All ARIA members who submit an entry agree that the decision of ARIA regarding the eligibility of an entry is final and no correspondence will be entered into.
- (I) All ARIA members who submit an entry and all ARIA Awards entrants agree to comply with the ARIA Code of Conduct and ARIA Behaviour Benchmark as published on the ARIA website from time to time. It is a condition of entry that all ARIA members that submit an entry must advise the relevant ARIA Awards entrant of the entrant's obligation to comply with the ARIA Code of Conduct and ARIA Behaviour Benchmark.
- (m) The person who submits the entry on behalf of each ARIA member acknowledges that they have read and accept the terms of this document. Any entry by an ARIA member constitutes acceptance of the terms of this document.

# 3. Determination of the Awards winners and rulings

#### 3.1 Voting and Award Determinations

All entries received by ARIA are first assessed to ensure that the relevant recordings are eligible for the particular Award category for which they have been entered. Once eligibility has been confirmed, all eligible entries received by ARIA are then presented for voting or determination as set out in Section 1 above and as set out below.

- (a) Five (5) awards categories are judged/voted by the Voting Academy which consists of over 800 representatives from every area of the music industry (**Voting Academy**).
- (b) Twenty (20) awards categories are judged/voted by specialist Judging Schools which consist of representatives experienced with that genre of music (**Judging School**).
- (c) Four (4) awards categories are determined by Public Vote. These are:
  - (i) Song of the Year;
  - (ii) Most Popular International Artist;
  - (iii) Best Australian Live Act; and
  - (iv) Best Video.
- (d) The ARIA Hall of Fame, the ARIA Icon Award and Lifetime Achievement and other special achievement Awards are awarded at the discretion of the ARIA Board.

#### 3.2 Rulings

(a) If any ARIA Awards entrant, nominee or winner (including to avoid doubt, an ARIA Hall of Fame inductee or a recipient of any special ARIA Award), or an ARIA member or person that submits an entry on behalf of an entrant, nominee or winner, engages in conduct:

- (i) that brings ARIA or the ARIA Awards into disrepute;
- (ii) that is not in line with the ARIA Code of Conduct or the ARIA Behaviour Benchmark (as published on the ARIA website); or
- (iii) that is misleading, for example where the initial entry and/or the subsequent conferral of the ARIA Award was based on false or misleading information,

then the ARIA Board reserves the right at any time, in its absolute discretion, to take whatever measures it considers necessary to preserve the reputation and integrity of ARIA or the ARIA Awards and to uphold the principles set out in the ARIA Code of Conduct and the ARIA Behaviour Benchmark.

- (b) The measures referred to in section 3.2(a) above may include, but are in no way limited to:
  - (i) refusing or disqualifying an ARIA Awards entry or nomination at any stage;
  - (ii) revoking or withdrawing an ARIA Award that has already been conferred; or
  - (iii) refusing entry to the ARIA Awards event (or subsequent ARIA Awards events).
- (c) If an ARIA Award is revoked by the ARIA Board after it has been presented, it is at the ARIA Board's discretion as to whether an award is given in that category for that year. The ARIA Board may also, at its discretion, subsequently restore an ARIA Award that has been revoked or undertake any further measures that it deems appropriate.
- (d) The ARIA Board's decision in relation to all matters under section 3.2 is final and no correspondence will be entered into.

# 4. General Eligibility Criteria

Eligibility for the Awards is defined by ARIA as follows:

#### 4.1 Entry

- (a) Only ARIA members are able to enter recordings/items for judging for the categories specified in section 1A (a), (b) and (c).
- (b) ARIA members may enter any artist / recording that satisfies the eligibility criteria set out in this document.
- (c) Recordings / Releases which have previously been nominated (in prior years) are ineligible.
- (d) An ARIA member can only enter its own artists (or those it distributes) and cannot enter the artists of another record label.
- (e) ARIA Levy Members may lodge up to twelve (12) entries in each category for which entries are accepted.
- (f) ARIA members may lodge up to eight (8) entries in each category for which entries are accepted.

#### 4.2 Definitions and Interpretation

- (a) **Album**: An Album is defined to be a release in physical and/or digital format which does not qualify as a Single and which satisfies other criteria particular to each category.
- (b) ARIA Levy Members (or Levy Members) means Sony Music Entertainment Australia Pty Ltd, Universal Music Australia Pty Limited and Warner Music Australia Pty Limited.
- (c) **Awards**: means the 2025 ARIA Awards which includes, to avoid doubt, the 2025 ARIA Fine Arts and Artisan Awards.

- (d) **Chart Eligibility Period:** means the relevant period during which ARIA published its charts, being the period commencing on 3 September 2024 and concluding on 1 September 2025 (inclusive).
- (e) **Credited Recording Artists**: Recording artists credited on the release must meet the Artist eligibility criteria (see Section below: **4.3 Artist Eligibility**) except in the case of Best Classical Album and Best Jazz Album refer to those particular category definitions.
- (f) **Current Eligibility Period**: means the period commencing 24 August 2024 and concluding on 22 August 2025 inclusive.
- (g) Eligibility of a Single: In the case of singles, a single is deemed eligible if the official media servicing date or video servicing date (determined by the 'published' date listed on the label or artist's YouTube channel) is within the Eligibility Period, where it is acknowledged that the track may have been previously available for individual digital purchase as part of an Album release outside of the Eligibility Period.
- (h) **Eligibility Period**: To be eligible for a nomination in the Awards (in any of the categories where an entry is required from ARIA members) the relevant item must have been released either:
  - (i) within the Current Eligibility Period; or
  - (ii) during the Previous Eligibility Period, provided that the item has not previously been entered in any ARIA Awards category.
- (i) **Judging School** means the persons described in Section 3.1(b).
- (j) **Multi-Artist Compilations**: Unless otherwise specified, multi-artist compilations are not eligible.
- (k) Multi-discs: Where the entered release comprises more than one disc, the discs must be sold as 'one set' to qualify.
- (I) **New Recordings**: New recordings, including new live recordings, of previously released compositions are eligible.
- (m) **Number of times a recording may be entered**: A recording may be entered in more than one non-genre category, but may not be entered in more than one genre category. Category definitions indicate those that are genre categories.
- (n) **Previous Eligibility Period**: means the two immediately preceding eligibility periods commencing 3 September 2022 and concluding on 23 August 2024. For the avoidance of doubt:
  - (i) the 2023 eligibility period spanned 3 September 2022 to 18 August 2023; and
  - (ii) the 2024 eligibility period spanned 19 August 2023 to 23 August 2024.
- (o) Release Date: Release date is defined as the date the product was first officially commercially released in physical or digital format in Australia through retail channels (which, for the purpose of clarity, may include online physical and digital retailers and/or the artist's own website).
- (p) Re-released Recordings: Re-released recordings are not eligible. All entries must comprise at least 50% (by number of tracks) previously unreleased recordings. Note that, for this purpose, remixed tracks do not count as previously unreleased recordings and the inclusion of any previously released material will render the particular track ineligible.
- (q) Single: A Single is defined to be a product released in physical and/or digital format and which either:
  - (i) contains up to five different songs, and with a music content of not more than 25 minutes duration; or

(ii) contains multiple versions of not more than five songs with a combined duration of not more than 40 minutes providing that the combined duration of the longest versions of each song does not exceed 25 minutes.

For the purposes of this definition, 'song' may include an instrumental only piece.

(r) Voting Academy means the persons described in Section 3.1(a).

#### 4.3 Artist Eligibility

- (a) Any artist that is a human and that satisfies any of the following criteria will be deemed to be eligible:
  - (i) Any artist who is an Australian citizen;
  - (ii) Any artist who was born in Australia;
  - (iii) Any artist with permanent residency status and who has lived in Australia for at least six months per year for the two consecutive years ending on 22 August 2025;
  - (iv) Any artist who has applied for permanent residency and has lived in Australia for at least six months per year for two consecutive years ending on 22 August 2025 and is signed to an Australian record label; or
  - (v) Any New Zealand artist who has lived in Australia for at least six months per year for the two consecutive years ending on 22 August 2025 and is signed to an Australian record label.
- (b) In the case of groups or duos at least 50% of the members of the group must satisfy at least one of the above criteria. Each entry must be accompanied by a list of group members appearing on the release.
- (c) The ARIA Board reserves the right to exercise its discretion to grant eligibility in special circumstances where, for example, the artist in question has a strong historical and cultural connection with Australia.

#### 4.4 Ineligibility

All entries will be reviewed for eligibility by the Eligibility Sub-Committee of the ARIA Awards Committee, which reserves the right to make the final judgement on category, artist and product eligibility. The Eligibility Sub-Committee will provide notice citing reasons for any entries deemed ineligible. The nominating ARIA member will have two (2) business days from such notice to respond, at which time the Eligibility Sub-Committee will review the entry and make a final decision.

#### 4.5 Artificial Intelligence Eligibility

- (a) Human Authorship Requirement
  - (i) Only human creators that meet the Artist Eligibility criteria set out in section 4.3 are eligible to be nominated and eligible to win an ARIA Award. The only exception to this rule are the categories of Best Australian Live Act, where the promoter (which may be a company) is eligible to receive the ARIA Award along with the Artist, and the category of Best Use of an Australian Recording in an Advertisement where an Eligible Agency along with the Artist may be nominated and awarded the ARIA Award.
  - (ii) Recordings/items that have been submitted for entry to the ARIA Awards that do not contain any human authorship are ineligible for consideration in any ARIA Awards categories.

#### (b) Limited Use of AI Elements

Recordings/items that incorporate elements of Artificial Intelligence (AI) may be submitted for entry, but only if a human is the primary creator of such recording/item and the human contribution is substantial and meaningful. All cannot be the sole or central element of any recording/item that is submitted for entry.

#### (c) Proof of Eligibility

- (i) Entrants must be able to provide proof upon request from ARIA to verify that a human is the primary creator of the recording/item that has been submitted for entry.
- (ii) For the Artisan Awards Categories the entrant must be able to provide sufficient evidence to ARIA that the technical work is the result of human effort.
- (iii) Final decisions regarding AI eligibility are at the discretion of ARIA and if necessary, the ARIA Board.

# 5. General Category Definitions

#### 5.1 Album of the Year

- (a) Judged by the Voting Academy.
- (b) Only Album recordings are eligible.
- (c) Solo artists and groups are eligible.
- (d) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period and must have appeared in the ARIA Top 50 Albums Chart or the ARIA Top 20 Australian Artist Albums Chart published during the Chart Eligibility Period.

#### 5.2 Michael Gudinski Breakthrough Artist

- (a) Judged by the Voting Academy.
- (b) Solo artists and groups are eligible, as are Album and Single recordings.
- (c) The recording must be released in the Current Eligibility Period or the Previous Eligibility Period and must have appeared in:
  - (i) the ARIA Top 100 Albums Chart;
  - (ii) the ARIA Top 100 Singles Chart;
  - (iii) the ARIA Top 50 Australian Artist Albums Chart; or
  - (iv) the ARIA Top 50 Australian Artist Singles Chart,

published during the Chart Eligibility Period.

- (d) Artists and groups are not eligible if they, or any member of the group:
  - (i) have previously been a final five (5) nominee in any ARIA Awards category with an Album or Single; or
  - (ii) if they have been in a group that has previously been a final five (5) nominee in any ARIA Awards category with an Album or Single; or
  - (iii) have had a previous Top 50 Album in the ARIA Albums Chart or Top 50 Single in the ARIA Singles Chart. A placing in an ARIA *genre* chart will not exclude artists from this category.
- (e) Note that a final five nomination for any of the Advertising ARIA Award categories **will not** preclude an artist or group from eligibility for this category.

#### 5.3 Best Solo Artist

- (a) Judged by the Voting Academy. There will be 10 nominees in this category.
- (b) Album and Single recordings are eligible.
- (c) If the product packaging refers to an individual and a band, the ARIA member must nominate whether that act is to be deemed a solo or group act for the Awards. A nominee for Best Solo Artist cannot be nominated in the Best Group Category.
- (d) The recording must be released in the Current Eligibility Period or the Previous Eligibility Period and must have appeared in:
  - (i) the ARIA Top 100 Albums Chart;

- (ii) the ARIA Top 100 Singles Chart,
- (iii) the ARIA Top 20 Australian Artist Albums Chart; or
- (iv) the ARIA Top 20 Australian Artist Singles Chart,

published during the Chart Eligibility Period.

#### 5.4 Best Group

- (a) Judged by the Voting Academy.
- (b) Album and Single recordings are eligible.
- (c) A group is comprised of two or more people. If the name on the product packaging is that of a band with no indication of any individual name, then such band will be considered in the Group category only. If the product packaging refers to an individual and a band, the ARIA member must nominate whether that act is to be deemed a group or a solo act for the Awards. A nominee for Best Solo Artist cannot be nominated in the Best Group Category.
- (d) The recording must be released in the Current Eligibility Period or the Previous Eligibility Period and must have appeared in:
  - (i) the ARIA Top 100 Albums Chart;
  - (ii) the ARIA Top 100 Singles Chart,
  - (iii) the ARIA Top 20 Australian Artist Albums Chart, or
  - (iv) the ARIA Top 20 Australian Artist Singles Chart,

published during the Chart Eligibility Period.

#### 5.5 Best Independent Release

- (a) Judged by a Judging School.
- (b) Solo artists and groups are eligible, as are Album and Single recordings.
- (c) The nominated recording must be released by an 'Independent' ARIA member. For the purpose of this Award category, an ARIA member will be considered to be Independent if the ARIA member:
  - or the nominated artist or group, funds its own A&R and marketing costs in respect of the nominated recording (a Levy Member may provide these funds, provided that these funds are not only recoupable but repayable), and undertakes its own local marketing and promotion (including media and DSP servicing) of the relevant release;
  - (ii) is not owned in whole or in part by any Levy Member or their respective affiliates or subsidiaries; and
  - (iii) has not entered into an exclusive licence agreement with a Levy Member for Australia in respect of the nominated recording.
- (d) Each entry in this category will need to be accompanied by a confirmation form, in the format prescribed by ARIA (see Appendix B), signed by the Chief Executive Officer, the Chief Financial Officer or a Director of the nominating ARIA member confirming the above criteria has been met during the Current Eligibility Period. ARIA may subsequently request the execution by the ARIA member of a Statutory Declaration (in the format provided by ARIA and appended to this document as Appendix A). The Statutory Declaration must be physically (not electronically) signed by the Chief

Financial Officer or Director of the nominating ARIA member and properly witnessed in accordance with the Statutory Declaration guidelines, and returned to ARIA within two business days of any such request from ARIA. ARIA will determine at its discretion whether the executed Statutory Declaration is valid.

- (e) The recording must be released in the Current Eligibility Period or the Previous Eligibility Period.
- (f) For the purpose of eligibility in this category of Best Independent Release only, EMI Music Australia Pty Ltd will also be considered to be a Levy Member.

#### 5.6 Best Adult Contemporary Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be directed toward Adult Contemporary formats.
- (e) The Album cannot be entered in any other genre category of the Awards.
- (f) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period and appear in the ARIA Top 100 Albums Chart or the ARIA Top 50 Australian Artists Albums Chart published during the Chart Eligibility Period.

#### 5.7 Best Blues & Roots Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period.
- (e) This category encompasses both contemporary and traditional blues forms and contemporary adaptations of Australian traditional music and/or folklore.
- (f) The Album cannot be entered in any other genre category of the Awards.

#### 5.8 Best Children's Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists, groups, soundtracks and various artist projects are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period.
- (e) This category encompasses recordings where the form and content are directed towards a pre-teen demographic.
- (f) In the case of compilations, entries must comprise 50% material recorded specifically for that compilation.
- (g) The Album cannot be entered in any other genre category of the Awards.

#### 5.9 Best Country Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period.
- (e) This category encompasses country music, both contemporary and traditional.
- (f) The Album cannot be entered in any other genre category of the Awards and must have appeared in either the Top 20 of the ARIA Country Albums Chart or the Australian Country Albums Chart, published during the Chart Eligibility Period.

#### 5.10 Best Dance / Electronic Release

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists, groups, and production teams are eligible.
- (c) Album and Single recordings are eligible provided they have been commercially released during the Current Eligibility Period or the Previous Eligibility Period.
- (d) Artists working primarily within the dance genre e.g.: House, Techno, Trance, Hardcore, Garage, Breakbeat, Drum & Bass, Disco and Electronica are eligible. In the case of a remixed Album or Single, the production team(s) and the original recording artist(s) must both meet the Artist eligibility criteria (see Section 4.3), and the release must qualify for inclusion in either the ARIA Albums or Singles chart. The ARIA member must also nominate whether the production team or the original recording artist would be the recipient of the ARIA Award in this category.
- (e) The Album or Single cannot be entered in any other genre category of the Awards. Note that, if an original version has been entered in the 'Best Pop' category, a remix is ineligible in the 'Dance / Electronic Release' category.
- (f) The Album or Single must have been surveyed for:
  - (i) the Top 20 ARIA Dance Singles, or
  - (ii) the Top 20 ARIA Dance Albums Chart,

published during the Chart Eligibility Period.

(g) Note that for the purpose of this category only, remixed tracks that meet all other relevant criteria, are eligible for entry in this category.

#### 5.11 Best Pop Release

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Album and Single recordings are eligible.
- (d) The Album or Single must be directed toward CHR/Top 40 formats.
- (e) The Album or Single cannot be entered in any other genre category of the Awards.
- (f) The recording must be released in the Current Eligibility Period or the Previous Eligibility Period and must have appeared in:

- (i) the ARIA Top 100 Albums Chart; or
- (ii) the ARIA Top 100 Singles Chart, or
- (iii) the ARIA Australian Artist Top 50 Singles Chart; or
- (iv) the ARIA Australian Artist Top 50 Albums Chart;

published during the Chart Eligibility Period.

#### 5.12 Best Rock Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be directed toward Contemporary Rock, Modern Rock and Active Rock formats.
- (e) The Album cannot be entered in any other genre category of the Awards.
- (f) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period and appear in the ARIA Top 100 Albums Chart or the ARIA Top 50 Australian Artists Albums Chart published during the Chart Eligibility Period.

#### 5.13 Best Hard Rock / Heavy Metal Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be directed toward Hard Rock or Heavy Metal formats.
- (e) The Album cannot be entered in any other genre category of the Awards.
- (f) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period and appear in the ARIA Top 100 Albums Chart or the ARIA Top 50 Australian Artists Albums Chart published during the Chart Eligibility Period.

#### 5.14 Best Hip Hop / Rap Release

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Album and Single recordings are eligible.
- (c) Solo artists, groups, and production teams are eligible. The Album or Single must be directed towards the Hip Hop / Rap format.
- (d) The Album or Single must be released in the Current Eligibility Period or the Previous Eligibility Period and must have appeared in:
  - (i) the ARIA Top 100 Albums Chart;
  - (ii) the ARIA Top 100 Singles Chart;
  - (iii) ARIA Top 40 Hip Hop/R&B Albums Chart

- (iv) ARIA Top 40 Hip Hop/R&B Singles Chart;
- (v) ARIA Top 20 Australian Hip Hop/R&B Singles Chart; OR
- (vi) ARIA Top 10 Australian Hip Hop/R&B Albums Chart,

published during the Chart Eligibility Period.

- (e) The Album or Single cannot be entered in any other genre category of the Awards.
- (f) The ARIA member must also nominate whether the production team or the original recording artist would be the recipient of the ARIA Award in this category.

#### 5.15 Best Soul / R&B Release

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Album and Single recordings are eligible.
- (c) Solo artists, groups, and production teams are eligible. Artists working primarily within the R&B, Soul, Funk, Reggae and Dancehall genres, are eligible.
- (d) The Album or Single must be released in the Current Eligibility Period or the Previous Eligibility Period and must have been surveyed for the:
  - (i) ARIA Top 40 Hip Hop/R&B Albums Chart; or
  - (ii) ARIA Top 40 Hip Hop/R&B Singles Chart;

published during the Chart Eligibility Period.

- (e) The Album or Single cannot be entered in any other genre category of the Awards.
- (f) The ARIA member must also nominate whether the production team or the original recording artist would be the recipient of the ARIA Award in this category.

# 6. Fine Arts Awards Category Definitions

#### 6.1 Best Classical Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible. Recordings where a minimum of 50% of artists featured on the Album packaging meet the Artist eligibility criteria (see Section 4.3) are eligible, even when ensembles or orchestras contain more than 50% of non-Australian artists.
- (d) The Album cannot be entered in any other genre category of the Awards.
- (e) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period and must have been surveyed for the ARIA Top 20 Core Classical Albums Chart during the Chart Eligibility Period.

#### 6.2 Best Jazz Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible. Recordings where a minimum of 50% of artists featured on the Album packaging meet the Artist eligibility criteria (see Section 4.3) are eligible, even when ensembles or orchestras contain more than 50% of non-Australian artists.
- (d) The Album cannot be entered in any other genre category of the Awards.
- (e) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period.

#### 6.3 Best World Music Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists and groups are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period.
- (e) This category encompasses predominately Traditional, Indigenous, Ethnic, Folk or Cross-Cultural music.
- (f) The Album cannot be entered in any other genre category of the Awards.

#### 6.4 Best Original Soundtrack or Musical Theatre Cast Album

- (a) Judged by a Judging School. Note: this is a genre category.
- (b) Solo artists, groups and various artist compilations are eligible.
- (c) Only Album recordings are eligible.
- (d) The Album must be released in the Current Eligibility Period or the Previous Eligibility Period.
- (e) Recordings of existing or planned musical theatre productions and soundtracks, scores and underscores for existing or planned film and television productions are eligible. Please note that: (i)

audio or audiovisual recordings of live performances or concerts; and (ii) filmed live compilations of performances from television programs, are ineligible for this category.

- (f) All Albums must comprise of 100% previously unreleased recordings, except:
  - (i) New recordings of previously released cast and/or show recordings are eligible.
  - (ii) In the case of compilation soundtracks, which must contain over 50% of previously unreleased material by tracks and/or time, and all artists must meet the Artist eligibility criteria (as set out in section 4.3).
- (g) The Album cannot be entered in any other genre category of the Awards.

# 7. Artisan Awards Category Definitions

#### 7.1 Best Cover Art

- (a) Judged by the Voting Academy.
- (b) This category awards original cover graphics by designers who meet the Artist eligibility requirements as set out in Section 4.3. Criteria for judging includes:
  - (i) originality of design concept;
  - (ii) overall design appreciation; and
  - (iii) merchandising impact.
- (c) Releases which are released during the Current Eligibility Period or the Previous Eligibility Period and meet the general eligibility criteria may be eligible for this Award category even though they may not meet specific criteria for other Awards categories. For the purposes of clarity, this may include a greatest hits Album or a new compilation of previously recorded works.
- (d) The Award in this category is presented to the designer(s) of the cover who must meet the general eligibility criteria for Artists (as set out in Section 4.3 of this document). In the case of a co-designer, all parties must individually meet the General Eligibility Criteria for Artists set out in Section 4.3.

#### 7.2 Engineer - Best Engineered Release

- (a) Judged by a Judging School.
- (b) A single track, multiple tracks (from a Single or Album release), or an entire Album may be submitted for each engineer. DVD releases are not eligible.
- (c) Only work released during the Current Eligibility Period or the Previous Eligibility Period will be considered.
- (d) Only mix engineers and co-mix engineers referred to in Section 7.2(e), are eligible to be considered for this category.
- (e) International product is eligible but mix engineer entrants must accord with the General Eligibility Criteria for Artists (as set out in Section 4.3 of this document). In the case of a co-mix engineer, all entrants must individually meet the General Eligibility Criteria for Artists set out in Section 4.3.
- (f) The release must appear in the ARIA Top 100 Albums Chart, The ARIA Top 100 Singles Chart, the ARIA Top 50 Australian Artists Singles Chart or the ARIA Top 50 Australian Artists Albums Chart published during the Chart Eligibility Period.

#### 7.3 Producer – Best Produced Release

- (a) Judged by a Judging School.
- (b) A single track, multiple tracks (from a Single or Album release), or an entire Album may be submitted for each producer. DVD releases are not eligible.
- (c) Only work released during the Current Eligibility Period or the Previous Eligibility Period will be considered.
- (d) Only producers and co-producers referred to in 7.3 (e) are eligible to be considered for this category.
- (e) International product is eligible, but producer entrants must accord with the General Eligibility Criteria for Artists (as set out in Section 4.3 of this document). In the case of co-producers, all entrants must individually meet the General Eligibility Criteria for Artists set out in Section 4.3.

(f) The release must appear in the ARIA Top 100 Albums Chart, the ARIA Top 100 Singles Chart, the ARIA Top 50 Australian Artists Singles Chart or the ARIA Top 50 Australian Artists Albums Chart published during the Chart Eligibility Period.

# 8. Public Voted Awards Category Definitions

In 2025, ARIA will present five Publicly Voted Awards. Listed below are the category definitions and nomination methodology for each category. Voters will be asked to select a winner from a nominee pool provided by ARIA or by the Voting Academy as applicable. The method of voting by the general public in each category will be determined by ARIA each year.

#### 8.1 Song of the Year

- (a) The nominee pool for Song of the Year will be drawn from eligible Single releases by Australian artists as defined in Section 4.3.
- (b) The ten highest selling Singles from these entries, based on ARIA sales statistics for the charts published between 27 August 2024 and 25 August 2025 inclusive, will form the nominee pool. Sales of different releases by the same artist during the period cannot be aggregated for the purpose of this category. Qualifying releases must have been released in the Current Eligibility Period or the Previous Eligibility Period, but may be an Album track subsequently released as a Single if the official media or video servicing date is within either Eligibility Period.
- (c) Products previously nominated for the ARIA Awards in this award category are ineligible.
- (d) An artist will only appear on the nominee list once, even if that artist has multiple releases that may otherwise be eligible.
- (e) ARIA members will be contacted in advance of the nominations announcement, so that they can provide the necessary collateral materials (e.g. cover art images).

#### 8.2 Most Popular International Artist

- (a) The nominee pool for Most Popular International Artist will be drawn from the ten highest selling artists, based on aggregated ARIA Album sales statistics for the charts published between 27 August 2024 and 25 August 2025 inclusive. Sales will be derived from the ARIA Top 100 Albums charts. Qualifying releases must consist of at least 90% new recordings and must have been first released either during the Current Eligibility Period or the Previous Eligibility Period.
- (b) ARIA members will be contacted in advance of the nominations announcement, so that they can provide the necessary collateral materials (e.g. cover art images).

#### 8.3 Best Australian Live Act

- (a) The Voting Academy will determine the final 10 nominees, which will then form the nominee pool for public voting.
- (b) ARIA members may enter eligible Artists as part of the normal entry process. The entries must meet the Artist eligibility criteria set out in Section 4.3 of this document.
- (c) The Artist must have performed live at no less than three ticketed events (which may include a music festival) held in at least one Australian State and / or Territory during the Current Eligibility Period. For the purpose of this category, the criteria is limited to live performances with an in-person audience. Performances that are live streamed only are not eligible.
- (d) The Award in this category will be presented to both the Artist and the promoter managing the relevant live performance or tour.

#### 8.4 Best Video

- (a) The Voting Academy will determine the final 10 nominee clips, which will then go forward for public voting.
- (b) The Award in this category is presented to both the artist and the Director of the entered video, both of whom must meet the General Eligibility Criteria for Artists as set out in Section 4.3 of this document.
- (c) If the Single was not commercially released then the media servicing date or the video servicing date (determined by the 'published' date listed on the label or artist's YouTube channel) must fall within the Current Eligibility Period or the Previous Eligibility Period.
- (d) ARIA members may enter eligible clips as part of the normal entry process.
- (e) ARIA members are requested to limit entries to those video clips that have had at least 50,000 online views in Australia (across all available service platforms) during the Current Eligibility Period, and may be asked to provide confirmation that the threshold has been met.

# APPENDIX C - ARIA Advertising Award Criteria

Best Use of an Australian Recording in an Advertisement.

#### 1. CONDITIONS OF ENTRY

- 1.1. Only Eligible Agencies may submit entries in this award category.
- 1.2. All materials submitted as part of the entry must be non-infringing authorised materials. If ARIA is advised that any materials submitted as part of an entry are infringing or unauthorised, then ARIA will determine in its sole discretion the eligibility of such materials and the eligibility of the entry.
- 1.3. ARIA will require each participating Eligible Agency to submit certain collateral and assets (for example, RAP Sheets, and YouTube links) as specified in the *Guide To Submitting Entries* which ARIA will make available to all participating Eligible Agencies. The conditions set out in the *Guide To Submitting Entries* also form part of these Conditions of Entry.
- 1.4. By submitting an entry, the participating Eligible Agency agrees that ARIA (and its licensees) may use the submitted collateral and assets in connection with the ARIA Awards voting platform, the ARIA Awards programs and ARIA Awards promotions, activities and marketing without payment to the agency, producer, the relevant artist, composer or any other person.
- 1.5. All entries must be submitted via the designated ARIA online platform within the specified timeframe.
- 1.6. All participating agencies which submit an entry agree that the decision of ARIA regarding the eligibility of an entry is final and no correspondence will be entered into.
- 1.7. All participating Eligible Agencies which submit an entry and all ARIA Awards entrants agree to comply with the ARIA Code of Conduct and ARIA Behaviour Benchmark as published on the ARIA website from time to time. It is a condition of entry that all participating Eligible Agencies that submit an entry must advise the relevant ARIA Awards entrant of the entrant's obligation to comply with the ARIA Code of Conduct and ARIA Behaviour Benchmark.
- 1.8. The person who submits the entry on behalf of each participating Eligible Agency acknowledges that they have read and accept the terms of this document. Any entry by a participating Eligible Agency constitutes acceptance of the terms of this document.

Please ensure you have checked your entry is eligible before submitting and paying your entry fee.

#### 2. VOTING AND AWARD DETERMINATIONS

- 2.1 All entries received by ARIA are first assessed to ensure that the relevant entry is eligible for the Award category. Once eligibility has been confirmed, all eligible entries received by ARIA are then presented for voting by the relevant Judging School. The members of the Judging School are asked to assess each entry to determine the best use of music in the service of the overall creative concept.
- 2.2 The ARIA Award for this category will be presented to the submitting advertising agency and the Artist that performs in the advertisement.

#### 3. RULINGS

- 3.1 If an ARIA Awards entrant, nominee or winner or person that submits an entry on behalf of an entrant, nominee or winner, engages in conduct:
  - (i) that brings ARIA, ARIA's members, any recording artists or the ARIA Awards into disrepute;

- (ii) that is not in line with the ARIA Code of Conduct or the ARIA Behaviour Benchmark (as published on the ARIA website); or
- (iii) that is misleading, for example where the initial entry and/or the subsequent conferral of the ARIA Award was based on false or misleading information,

then the ARIA Board reserves the right at any time, in its absolute discretion, to take whatever measures it considers necessary to preserve the reputation and integrity of ARIA or the ARIA Awards and to uphold the principles set out in the ARIA Code of Conduct and the ARIA Behaviour Benchmark.

- 3.2 The measures referred to in section 3.1 above may include, but are in no way limited to:
  - (a) refusing or disqualifying an ARIA Awards entry or nomination at any stage;
  - (b) revoking or withdrawing an ARIA Award that has already been conferred; or
  - (c) refusing entry to the ARIA Awards (or subsequent ARIA Awards events).
- 3.3 If an ARIA Award is revoked by the ARIA Board after it has been presented, it is at the ARIA Board's discretion as to whether an award is given in that category for that year. The ARIA Board may also, at its discretion, subsequently restore an ARIA Award that has been revoked or undertake any further measures that it deems appropriate.
- 3.4 The ARIA Board's decision in relation to all matters in this Rulings section are final and no correspondence will be entered into.

#### 4. ELIGIBILITY CRITERIA

- 4.1 Only agencies that have made the annual OSOA Pledge and paid the relevant fees for the current award period are able to enter Advertisements for judging.
- 4.2 To be eligible for nomination, the relevant Advertisement must have been first published in Australia within the Current Eligibility Period.
- 4.3 Eligible Agencies may enter any Advertisement that satisfies the eligibility criteria set out in this document.
- 4.4 Advertisements which have previously been nominated (in prior years) are ineligible.
- 4.5 An agency can only enter its own Advertisements and cannot enter the Advertisements of another agency or entity.
- 4.6 The Eligible Agency must have in place valid licences for the synchronisation of the sound recordings and musical works that are embodied in the Advertisement that is submitted for entry.
- 4.7 An Advertisement will be eligible for consideration in this category if it satisfies the following criteria:
  - (a) The Advertisement was created at the direction of the Eligible Agency; AND
  - (b) The music sound recording used in the Advertisement is controlled or distributed by an ARIA member, and recorded and performed by:
    - (i) Any artist who is an Australian citizen;
    - (ii) Any artist who was born in Australia;
    - (iii) Any artist with permanent residency status and who has lived in Australia for at least six months per year for the two consecutive years ending on 31 August 2025:
    - (iv) Any artist who has applied for permanent residency and has lived in Australia for at least six months per year for two consecutive years ending on 31 August 2025 and is signed to an Australian record label; OR

- (v) Any New Zealand artist who has lived in Australia for at least six months per year for the two consecutive years ending 31 August 2025 and is signed to an Australian record label.
- 4.8 In the case of recording artists that are groups or duos, at least 50% of the members of the group must satisfy at least one of the above criteria in section 4.5(b). Each entry must be accompanied by a list of group members appearing on the recording.
- 4.9 The ARIA Board reserves the right to exercise its discretion to grant eligibility in special circumstances where, for example, the artist in question has a strong historical and cultural connection with Australia.
- 4.10 All entries will be reviewed for eligibility by the Eligibility Sub-Committee of the ARIA Awards Committee, which reserves the right to make the final judgement on eligibility. The Eligibility Sub-Committee will provide notice citing reasons for any entries deemed ineligible. The nominating agency will have two (2) business days from such notice to respond, at which time the Eligibility Sub-Committee will review the entry and make a final decision.

#### 5. DEFINITIONS AND INTERPRETATION

#### Advertisement means:

- (a). any advertising, marketing communication or material which is published or broadcast using any Medium or any activity which is undertaken by, or on behalf of an advertiser or marketer:
  - over which the advertiser or marketer has a reasonable degree of control, and
  - that draws the attention of the public in a manner calculated to promote or oppose directly or indirectly a product, service, person, organisation or line of conduct,
- (b). but does not include:
  - labels or packaging for products
  - corporate reports including corporate public affairs messages in press releases and other media statements, annual reports, statements on matters of public policy

#### **Eligible Agencies** means advertising agencies that:

- (a) operate under an Australian Company Number/Australian Business Number; and
- (b) have formally made the annual OSOA pledge and paid the relevant entry fees.

**Current Eligibility Period**: means the period commencing 1 September 2024 and concluding on 31 August 2025.

**Judging School:** means the persons determined by ARIA to cast votes to determine the winner in this award category.

**Medium** means any medium whatsoever including without limitation cinema, internet, social media, outdoor media, print, radio, telecommunications, television or other direct-to-consumer media including new and emerging technologies.

OSOA means the Our Soundtrack Our Ads campaign.

**OSOA Pledge**: means the advertising agencies which have formally committed to OSOA, and paid the relevant annual pledge fee.
